The Let Girls Learn initiative is an effort by the United States Government to provide the public with meaningful ways to help girls around the world get a quality education. A key part of the program involves the reduction of barriers that prevent young girls from completing their education. Around the world, 62 million girls are not in school, but with Let Girls Learn different organizations work together to help girls complete the education they deserve. This program helps, gives them a chance to advance their knowledge and possibly make a difference in the world.

"This will help other countries bring themselves into the 21st century and allow women to gain more rights and empower others to change the world," Rebecca Roberson ('18) said.

When other countries deny girls the opportunity to obtain a decent education, they limit the girl's ability to change their standard of living. An education reduces the likelihood of early forced marriages, and other forms of violence. If girls get a fair education there can be a ripple effect on her family and on her society. In some countries these effects can change the lives of these girls. For example, if all women in sub-Saharan Africa obtained a secondary education. 1.8 million lives would be saved each year. A World Bank study found that every year of

secondary school education is correlated with an 18 percent increase in a girl's future earning power

"I think that girls in other countries don't get the same opportunities that boys do because they are still deemed worthless. Girls are still seen as not capable to do things that boys can do so they aren't given the same opportunities," Maria Asanza ('17) said. Since the start of Let Girls

Learn, President Obama and The First Lady have been working with the Peace Corps and United States Agency for International Development (USAID) to help change the standard of how of girls are regarded around the

world. So far the USAID has made huge progress, providing 35 million t-extbooks and other teaching materials, and training 300,000 teachers worldwide. Over the past 15 years they have also helped Ethiopia achieve 95% enrollment in primary school and started supporting education programs in 18 African countries.

In some countries, fewer than 10% of teenage girls complete their secondary school. Other organizations are stepping up to the plate and helping other countries create gender equality. The Peace Corps organizes and leads GLOW (Girls Leading Our World) Camps around the world to promote gender equality and empower young women and have

served a total of 30,000 people The girls who can get this knowledge can travel to other countries and spread their awareness and help others," Angeline Martone ('17) said.

In the Florida Senate, lawmakers currently debate raising the state minimum wage. Instead of being \$8.05 and hour, the new minimum wage could raise to \$15 an hour. Despite heavy skepticism,

the Florida Senate Education Committee continues their effort to extend teacher bonus based on that teacher's SAT or ACT scores. according to fsba.org. The Senate gave narrow support of this issue, and the chances of the teacher bonus still remain questionable.

A legislation signed by governor Rick Scott in the middle of 2015 states that students in Florida schools will spend no more than 45 hours a year on standardized testing. This reduced the amount of Sunshine State Standards testing students do throughout

#### the year.

Another big issue, both throughout the state of Florida and the United States, is abortion. A law currently being debated in the Senate prohibits anything related to abortion, including performing, attempting to perform, or assisting an abortion. Those with unwanted pregnancies have to require the Office of Adoption and Child Protection to gather attorneys that provide adoption services for their unwanted child.



- There is no fee to fill out the FAFSA.
- Any graduating senior planning to attend a two to four year college or university should fill out the FAFSA.
- The FAFSA gathers info that can be used to provide the proper amount of financial aid to a student in the form of government subsidized student loans and pell grants.
- The FAFSA is free to apply for and to use.
- Each school has a distinct deadline for the FAFSA, so seniors should check with the school.

sending out an offensive tweet directed towards the LGBT community in Dallas, Texas.



"[SaltNation] is unique because we come from a



Even when the Tampa Bay Buccaneers improve their record, the coach receives the pink slip to no longer show up to work. After winning four more games in the 2015 season, head coach Lovie Smith received a call informing him that the Buccaneers wanted to fire him. Smith's expertise is on the defensive side of the football, yet the Buccaneers went down in scoring defense this year, as they finished 26 out of 32.

"I get the firing of Lovie [Smith], but you need more time than two years. The team won four more games, so there was improvement," Trent Nardin ('17) said.

The Buccaneers went in house replacing Smith for the vacancy, by promoting offensive coordinator Dirk Koetter. The Buccaneers defense struggled, but Koetter helped drastically improve a struggling offense. Koetter took over the third worst offense in the NFL in total vards, and moved them up to the top five.

"[Dirk] Koetter really helped improve the offense, and I'm excited to see how he fairs as head coach." Nardin said.

Even with uncertainty ahead for the franchise, the Buccaneers showed positive signs moving forward. Number one pick Jameis Winston lived up to the bill in his rookie campaign. Winston threw for 4,042 yards and 22 touchdowns, while running for six

more. Although he struggled early

in the season with interceptions he kept improving throughout the season.

"Jameis surpassed my expectations this year, especially after losing the way he did to Marcus Mariota," Ryan Penland ('16) said.

Doug Martin also played well in 2015, finishing with 1,402 rushing yards and second in the league in that category. Martin's contract expires this offseason, and looks to draw significant interest from teams around the league.

"Doug Martin really shocked me, but who knows if he'll be back," Nardin said.

Gerald McCoy continued his success on the defensive side of the ball, making his fourth straight

Well-rounded athlete Rachel Kling's ('16) list of athletic history contains sports like figure skating, snowboarding, and volleyball. By participating in numerous sports Kling understands the importance of knowing the game.

"Focus on the fundamentals. because if you know how to play properly from the basics, it will

be harder to mess up and hurt yourself," Rachel Kling ('16) said. An athlete may set himself

or herself up for success by obtaining all the knowledge on the sport possible. Practicing day after day helps athletes not only play better, but also keep them safe in the game.

A common injury in sports is a concussion, which is an injury that occurs after a player receives a blow to the head or body that violently shakes the head resulting in a brain injury. This injury is common due to the fact that most sports require a fast pace. According to the Mayo Clinic, there are more than 3 million cases in the US every vear. After eight years playing softball, Madison Bell ('17) understands the odds of receiving a concussion.

"My injury occurred at softball practice. I was standing at the bucket collecting the balls that were being hit by the batter. When I was watching the batter, making sure I didn't get hit by the ball being hit, someone called my name and when I turned around I got hit in the forehead by the ball that the girl threw," Bell said.

Every injury requires different methods of recovery, which makes it important to obtain knowledge on the injury a player suffers from. By being knowledgeable on the recovery process of different injuries, players ensure a normal recovery that doesn't make the injury any worse

"To make sure I had a fast recovery I stayed in bed a couple days and slept. When I wasn't sleeping, I had all the lights off and was probably eating. I couldn't watch TV, read, or be on my phone because I would get a

really bad headache," Bell said. While an injury results in a temporary pause in athletic participation, players ensure recovery by following orders from their doctors. Pay attention while active, and make sure to follow any direction given by coaches to avoid danger.

The use and consequences of performance-enhancing drugs remain a very controversial topic over the past several years.

According to sportslaw.uslegal. com, major professional sports in the United States coordinate their own drug testing and use policies through consent from the professional athletes from their individual contract. That same website states that the NCAA (National Collegiate Athletic Association) has similar laws. Intercollegiate associations require their athletes to sign a consent form in order to receive admission to play any sport under the NCAA. The NCAA's established drug abuse policies make testing for street and performance-enhancing drugs a

requirement for it's athletes Opinions differ on the severity of the consequences given to professional and collegiate athletes who use performanceenhancing drugs. Some, like Spencer Edwards ('18) believe that drug abuse is not taken seriously enough.

"I think drug abuse is taken too lightly. It has become too common, as if the athlete has to take performance-enhancing drugs to be able to perform well at that level," Edwards said.

Certain fans justify the use of performance-enhancing drugs in today's sports environment, considering them a necessity to compete.

Professional sports also struggle dealing with performanceenhancers. Performance enhancing drugs resulted in nearly 39% of Major League Baseball suspensions.

However, the dangers of abusing performance-enhancing drugs remain severe. Symptoms of performance-enhancing drug abuse include liver abnormalities. tumors, heart and circulatory problems, psychiatric disorders, and in extreme cases, death.

There is no newfound way to completely prevent the use of performance-enhancing drugs in professional and collegiate sports. Though the effects of abusing are severe, the controversial topic on whether or not they are 100%justifiable by the sports watching population remains an issue.

In preparation for the remaining District games, the girls have multiple practices a week to improve their skills.



On Monday, Feb. 15, the 58th annual Grammy ceremony airs at 8 p.m. EST on CBS. Artists will


be recognized with awards such as Album of the Year and Song of the Year at the event, hosted by LL Cool J.





Netflix recently began advertising the series, Making a Murderer. The series is supposed to be a documentary that provides the audience with evidence. However, there have been claims that the series is not a documentary and that the producers manipulated the evidence to support the main character's side.

The series revolves around a man, Steven Avery, who was wrongfully put in jail for 18 years. The Avery family lived in Wisconsin and owned an auto salvage yard. To the people in the town, the Avery family was mysterious. Despite having an alibi, Avery ended up being convicted of sexually assaulting Penny Beerntsen.

The Innocence Project, an organization that fights for wrongfully convicted people, demanded new DNA tests to be taken. They needed evidence to be found, proving Avery's innocence. When new DNA test results came back, they matched a local man named Gregory Allen that was a previous suspect that was overlooked.

After spending 18 years in jail, he was set free because of the new DNA evidence. Avery just spent 18 years in jail for a crime that he did not commit, so, he filed a lawsuit against the Manitowoc County Police Department. Those people essentially took

away 18 years of Avery's life. With help from the Innocence Project, Avery filed a lawsuit against the local officials that put him in jail. He was suing them for \$36 million over the wrongful conviction.

Two years after Avery was exonerated from jail, he was accused of the murder of Teresa Halbach. Avery's attorneys claimed that the Manitowoc Police Department framed Avery

for the murder because of the lawsuit he filed.

Brandon Dassey, Avery's nephew, made claims during an interview that he and Avery sexually assaulted and then murdered Halbach in their trailer on their auto salvage property. Because of this, Brendan was sentenced to life in prison at the age of 16. At this point, Avery's family hired two prestigious defense attorneys, Dean Strang

and Jerry Buting to fight for him. The attorneys found evidence that helped support the fact that Avery was innocent. However, the prosecutors also found DNA evidence inside the car. Avery's blood laid inside Halbach's car. which was found on their auto salvage property. The prosecutor also found Halbach's key inside Avery's trailer.

Strang and Buting claimed that the officials placed the blood and key to frame Avery. To support this, they showed evidence of a tampered blood vile that belongs to Avery.

Despite evidence found from

defense attorneys, Avery was found guilty of two out of three counts for the death of Halbach and sentenced to life in prison. As for Dassey, he was sentenced to life in prison but is eligible for parole in 2048.

Thousands of people took to online petitions in hopes to free Avery. There is now a Change.org page that was made by

A curious case of Affluenza

In December, an eighteen-year old boy named Ethan Crouch finally got handcuffed alongside his mother in Mexico over an incident that happened in 2013. "Affluenza", the ridiculous, made-up term used to describe this case, defends the boy's lifetaking actions. What happened back in 2013 led to his recent arrest. Sierra Schultz ('18) describes the incident this way.

"He was driving drunk and had teens in the back of his truck and he hit a whole bunch of people on the side of the road who were helping someone that had car troubles. This caused his friends to be ejected from the truck and he killed everyone that he hit. His lawyer used the defense of him being rich and privileged to say that his parents never imposed any values in him because he was never given consequences as a child," Schultz said.

Crouch's recent arrest is due to his escape to Mexico with the help of his motherly accomplice, after he violated his probation. This sickening story's twists includes some people who believe Crouch's parents deserve to receive full punishment, and others believe that Crouch deserves all of the responsibility.

"I think Ethan deserves more punishment He was the intoxicated driver and should have been more aware of what he was doing and been responsible enough to take a cab or call someone for a ride," Joey Weierheiser ('18) said.

Supporting Weierheiser's argument, Crouch made the decision to drink and then get behind the wheel. Growing up spoiled and never hearing the word "no" come

out of his parents' mouths, Crouch first got away with his terrible crime all because of the word "affluenza", made up by a psychiatrist. The outcome of this case may affect the way others look at teens that act similar to Crouch.

"Other teenagers will probably be more likely to deter their peers from driving while intoxicated by taking precautions like collecting car keys before a party. Teens will be less likely to get in the car with someone who has been drinking no matter the

circumstances," Schultz said. Although Crouch committed the crime, the "affluenza" defense highlights his

mother and father's lack of parenting skills. "It shows some sort of a careless type of parenting, and they give him the idea that the laws do not apply to him due to being in an

affluent family," Weierheiser said. Clearly not thinking before his acting, Crouch's unforgivable incident teaches not only him a lesson, but teens around the world as well.

"Teens should exercise extreme measures when getting behind the wheel because they are inexperienced drivers. This case should emphasize the dangers of driving under the influence because driving while intoxicated can impact not only your life, but the lives of many others as well", Schultz said.

The term "affluenza" should not continue as a word in these types of cases. It acts as a literal "get out of jail" free card, as shown through Crouch's trial. Those who make foolish decisions and commit crimes deserve to live behind bars
